### **REGISTRATION RULES**

#### **Art & Craft: \$75 before 7/1/2018.**

This category is only for handmade arts & crafts, no manufactured items or direct sales representatives.

#### **Commercial Vendors: \$150 before 7/1/2018**

This category is for direct sales companies, clothing, purses, costume jewelry, all manufactured items, games or activity vendors.

#### **Electric: \* additional \$35 before 7/1/2018**

**ALL VENDORS must add \$50 late fee after 7/1/2018 – NO EXCEPTIONS.**

**\*Electric booths available on a first come, first serve basis before 7/1/2018, no electric available after 7/1/2018.**

#### **Non-Profit 501(c)3: \$65 before 7/1/2018**

Only organizations who can show a State of Ohio 501(c)3 license can receive this discounted rate.

#### **Food & Drink Vendors: \$175 before 7/1/2018**

We have limited availability for Saturday food vendors, you must be approved by director and provide a State of Ohio mobile food license with registration. **CANNOT SELL POP!**

**Vendors must provide** their own tent cover (**this is required**) and tables and chairs. Easy-up tents are fine. We mark the pavement / curbs with booth numbers.

**Fair volunteers** will be available at 6:30 am to help with directions only. We do **NOT** provide staff to help load and unload your vehicles. You need to unload and move your vehicle **before** setting up. This helps everyone get down the narrow streets in a timely manner. Spaces are 15 ft wide x 10 ft deep. **NO SET-UP BEFORE 6:30 am.**

**Vendors are NOT** permitted to sell any food or beverage from their booth, unless they have been pre-approved by the Director. Email: [info@MaumeeSummerFair.com](mailto:info@MaumeeSummerFair.com) to request approval. **Cannot** sell pop, absolutely **NO** water giveaways!

**Booth numbers** are assigned on a first-come basis. **We do not guarantee your location preference.** Vendors will be placed where appropriate for their category. It is your responsibility to sign up early for the best chance at getting the same location as last year. All registration forms are dated when they are received at the MUBA office.

**Electrical Outlets:** We have just a few booths with electrical outlets at an **additional cost of \$35 per booth** (one electrical plug-in per booth). These are available on a first-come basis, and you will need to supply your own heavy-duty 50 to 100-foot electrical cord. We cannot guarantee electric availability.

**Booth Confirmation:** You will be notified on **July 30, 2018 via EMAIL** with your BOOTH NUMBER and fair map indicating vendor parking areas, so it is imperative that you print your email **legibly** on the registration form.

**Vendor Hours:** Vendor set-up is Saturday 6:30 to 8:45 am. **NO** early set-up. **NO** vehicles in display areas after 8:45 am. **NO breakdowns before 5 pm.** *Vendors leaving before 5 pm will not be invited back next year.*

**State of Ohio** requests that all vendors have a license to sell items. While we do **NOT** monitor compliance with this law, it is up to you, the seller, to follow State requirements should they decide to spot-check your booth.

**Food Vendors** are required to provide a copy of their State of Ohio mobile food license with their registration.

- **Vendor registrations *received* after 7/1/2018 at 5:00 pm MUST INCLUDE the \$50 late fee, no exceptions.**

- New Vendors must include product photos or photocopies with the registration and payment.
- PLEASE TYPE OR PRINT LEGIBLY!
- NO VENDORS can sell pop or water, or give away water.
